

# Information on personal data protection in connection with video monitoring in the facilities of Operator Gazociągów Przesyłowych GAZ - SYSTEM S.A. (GAZ-SYSTEM)

## Why do we need your personal data?

We collect your personal data revealing your image recorded by video surveillance because we need it to ensure the safety of persons and property in the monitored area.

Entrance to the monitored area will give us personal data about your image. Hiding your image, such as by wearing dark glasses or a hat that covers up or makes it difficult to discern your image, may result in you being ordered to leave the facility or area being monitored.

## Who do we share the data with?

The following entities may be recipients of your data:

- our employees or cooperators,
- members of GAZ-SYSTEM authorities,
- entities authorised under applicable laws (in particular courts, state authorities, institutions),
- entities providing services to GAZ-SYSTEM on the basis of concluded agreements, in particular entities providing security services for people and property, security systems, CCTV maintenance, IT services and new technologies, postal and courier services, document destruction and archiving, accounting and financial services.

## Do we transfer data to third countries or international organisations?

We do not transfer data to international countries or organisations that do not protect them adequately.

## What is the legal basis for processing?

Your personal data in the form of image will be processed for the purpose of ensuring safety and order on the premises of Operator Gazociągów Przesyłowych GAZ-SYSTEM S.A. - the basis for the processing is the legitimate interest of the administrator (Article 6 (1) (f) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter referred to as RODO). The legitimate interest pursued by the Controller is to ensure the safety of persons in the buildings and on the premises managed by the Controller, including ensuring the safety of employees and ensuring the security of the property of the Controller, employees and visitors.

### How long will we process the data?

Records from monitoring will be stored until they are overwritten (depending on the size of the recordings), up to a maximum of 3 months, with the exception of situations where the recordings have been secured, in accordance with separate regulations.

### What are your rights?

In justified circumstances, You have the right to:

- access to your personal data, i.e. your right to know what data we process, how we process it and for what purpose,
  - restriction of processing, i.e. request to restrict data processing to storage. The revocation of the restriction of processing may take place after the cessation of the prerequisites justifying the restriction of processing,
  - to object to the processing, i.e. to stop processing your personal data for the purpose indicated above, if you believe that we
    are violating your rights in connection with the processing of the data obtained
  - make a complaint to the supervisory authority the President of the Office for Personal Data Protection, if you think that the processing of your personal data in the form of image violates the provisions of the RODO.

### Do we make automated decisions, including profiling you?

We do not make automated decisions, including profiling you based on your personal data.
