

Information on the protection of personal data for natural persons concluding and implementing civil law contracts with Operator Gazociągów Przesyłowych GAZ-SYSTEM S.A. (GAZ-SYSTEM)

Why do we need your personal data?

We collect your personal data because they are necessary for us to conclude and perform the contract, as well as for the purpose of maintaining business contacts in connection with the conclusion and performance of the contract.

With whom do we share your personal data?

The following entities may be the recipients of the data:

- our employees or associates,
- members of GAZ-SYSTEM governing bodies,
- entities authorized under applicable law (in particular courts, state authorities, institutions),
- entities providing GAZ-SYSTEM with services based on concluded agreements, in particular entities providing GAZ-SYSTEM with IT services and new technologies, postal and courier services, destruction and archiving of documents, accounting and financial services, protection of people and property.

Do we transfer data to third countries or international organizations?

We do not transfer personal data to third countries or international organizations that do not adequately protect them.

What is the legal basis for processing?

The legal basis for the processing of your personal data is a civil law contract to which you are a party (Article 6(1)(b) of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46 / EC (General Data Protection Regulation), hereinafter "GDPR"). Providing personal data for this purpose is voluntary, however, failure to provide them will prevent the conclusion of a civil law contract. In addition, in order to maintain business contacts, your personal data will also be processed on the basis of art. 6 sec. 1 letter f GDPR. For this purpose, providing personal data is voluntary, however, failure to provide personal data may significantly hinder contact with you, and thus hinder the performance of a civil law contract.

For how long will we process the data?

Personal data will be processed for the period necessary to maintain related contacts with the conclusion and performance of the contract, as well as for the period necessary to store this contract for archival purposes.

Do we make automated decisions, including profiling you?

We do not make automated decisions, including profiling you based on personal data.

What are your rights?

You have the right to:

- access to personal data, i.e. the right to obtain information on what data, how and for what purpose we process,
- rectification, i.e. a request to update data if it turns out that incorrect data has been collected or that it is no longer valid,
- deletion of personal data, i.e. requesting removal of all or part of personal data. Zf the request is justified, we will
 immediately delete the data,
- restriction of processing, i.e. requests to limit the processing of data to their storage. The restriction of processing
 may be revoked after the premises justifying the restriction of processing have ceased to exist,
- objection to processing, i.e. stopping the processing of personal data for the purpose indicated above, if in your opinion we violate your rights in connection with the processing of the data provided,
- lodge a complaint against us to the President of the Office for Personal Data Protection, if you believe that the
 processing of your personal data violates the law.
