

Instructions for completing the Questionnaire

This Questionnaire serves as a tool for GAZ-SYSTEM S.A. to conduct a non-binding market screening entitled: **"Hydrogen Map of Poland"**. The survey is to provide details and up-to-date information on the locations of hydrogen demand and supply in Poland until 2050. On the basis of reliable market data derived from the Questionnaire, it will be possible to develop assumptions related to the construction of infrastructure and **preliminary outline of hydrogen pipeline routes in Poland** along with volume, timeline and coordinates.

1. The Questionnaire was prepared in Excel – file name: **„QuestionnaireHMP_2024”**.
2. Respondents fill in only the coloured cells marked as below:

Please complete only the cells marked in this colour



3. The Questionnaire contains **open-ended** as well as **closed-ended** questions (by selecting a specific option from a drop-down list).
4. The Questionnaire is divided into six **thematic sheets** :

Introduction

Basic information

Production

Consumption

Distribution

Storage

- 1) **Introduction** (orange)
- 2) **Basic information** (blue)
- 3) **Production** (green)
- 4) **Consumption** (red)
- 5) **Distribution** (yellow)
- 6) **Storage** (purple)

The sheets cover basic information about the entities participating in the survey and include a breakdown into four main segments of hydrogen economy in Poland.

5. **"Introduction"** sheet - contains information about the "Hydrogen Map of Poland" project and the date of the market screening procedure. There you will also find contact details necessary to send the completed questionnaire.
6. **Each Questionnaire participant** should complete the sheet: **"Basic information"**.

- This sheet is **uniform for all participants** - regardless of the hydrogen projects they are involved in.

7. After completing basic information, Market Screening Procedure participants shall proceed to the next sheet of the questionnaire. Select the sheet corresponding to the **main line of business** of your company.

- If your company is only involved in **a single segment** of the hydrogen economy (production, consumption, distribution or storage), fill in the data for **that segment** that is of relevance to you.
- If your company is involved in **two or more** segments of the hydrogen economy, complete all sheets **applicable to your business**.

8. By default, the sheets contain 3 columns to enter information on the hydrogen projects implemented by your company – Project A, Project B and Project C.

- If the company pursues **more than 3 hydrogen projects**, the respondent can include additional column(s) as needed and name it/them accordingly: Project D, Project E, etc.
- To do this, select the entire H column with the **left mouse button**.
